# The 2040 climate target – next steps

#### The 2040 climate target: ambition

- Following the departure of Frans Timmermans, Commissioner Šefčovič was elevated to executive vice president in charge of the European Green Deal and Wopke Hoekstra was nominated to become the incoming climate action commissioner
- Following their hearings in the European Parliament's Environment Committee, MEPs asked them additional questions in writing
- Both Commissioners-designate committed to "defend a minimum target of at least 90% net reduction by 2040". This is in line with the recommendation of the European Scientific Advisory Board for Climate Change

### The 2040 climate target: the Scientific Board's recommendation (1/2)

In light of the evidence summarised in the previous section, the Advisory Board recommends a 2040 emission reduction range of 90–95% compared to 1990, corresponding to a greenhouse gas budget of 11-14 Gt CO₂e over the period 2030-2050.

- 1. Aim for the highest ambition in domestic emission reductions and sustainable carbon removals, while accounting for feasibility constraints, environmental risks and technological deployment challenges.
- 3. **Pursue sustainable net-negative emissions after 2050**, as required under the European Climate Law, which would help manage temporary temperature overshoots and support the international balance of greenhouse gas emissions.









Figure 1: Cap in Reform scenario (adjusted to sectoral scope of LIMES-EU)

#### The 2040 climate target: policy timeline

The Climate Law also requires the European Commission to propose a 2040 climate target in 2024

- 27 October 2023: The European Climate Stocktake EU and global progress towards the goals of the Paris Agreement
- By end May (planned for Q1) 2024: The 2040 target should be proposed within six months of the first global stocktake carried out under the Paris Agreement, which will take place in Dubai at COP28 in December this year
